**DIRECTIONS FOR USE:** Cutter Skinsations repels mosquitoes, black flies, stable flies, biting midges, deer flies, ticks and chiggers. Hold container 15-20 cm away, apply sparingly, not under clothing and only when necessary. Reapply after 3 hours if necessary. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Wash hands, after application. Do not spray in enclosed spaces. Will not damage nylon, cotton or wool. Avoid contact with plastic, watch crystals and synthetic fabrics such as acetate, rayon and dynel. May damage leather, furniture finishes, plastics and painted surfaces.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Supervise applications on children. Do not use on infants under 6 months of age. In 6 month to 2 year olds, do not apply more than once a day. Not for daily use. Avoid application to hands. In 2-12 year olds, DO NOT apply more than 3 times per day. DO NOT INHALE SPRAY MIST. Avoid contact with eyes and mouth, cuts, wounds and sunburned skin. Keep container away from flame or spark.

**FIRST AID: If in eyes:** Remove contact lenses, and flush with water for 15 minutes. **If inhaled:** Give artificial respiration if indicated. Seek medical attention. If irritation or other adverse effects develop wash with soap and water immediately. Seek medical attention, if symptoms persist. **If swallowed,** seek medical attention or contact a poison control centre IMMEDIATELY. Always take container label with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse container. When container is empty, discard in household garbage.
