## **DIRECTIONS FOR USE**

To be used only in the manufacture, formulation, or repackaging of a product which is registered under the *Pest Control Products Act*.

## **PRECAUTIONS**

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

Corrosive to eyes and skin. Do not get in eyes or on skin. Harmful if swallowed or inhaled. Corrosive. Causes skin and eye irritation. May produce severe burns. Potential skin sensitizer. Avoid spray mists. Sodium hydroxide solutions of Preventol CMK can cause permanent eye damage.

Personal Protective Gear required: Wear a long sleeved shirt, long pants, goggles or face shield, chemical resistant gloves and apron when handling the product.

## **FIRST AID:**

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

## **ENVIRONMENTAL HAZARDS:**
