DIRECTIONS FOR USE: To be used in the manufacture of insecticides which are registered under the Pest Control Products Act. This product is designed for use at 3.75% (wt.) with approved solvents and propellents to produce a water-based pressurized space spray. Read technical bulletin for formulation details.
