Do not take internally. Do not get in eyes or on skin or clothing. Wash thoroughly after handling. Wash contaminated clothing before reuse. Flush contaminated eyes with plenty of water and seek medical attention. Avoid prolonged breathing of vapours and spray mist. Store away from food, feedstuffs and domestic water supplies. Do not spray ornamental or edible plants. Store and use away from open flame and heat. Do not use in animal buildings or poultry houses.

FIRST AID: This product contains petroleum distillates; if swallowed do not induce vomiting. Call Poison Control Centre and seek prompt medical attention. Flush contaminated eyes and skin with plenty of water, and for eyes get prompt medical attention.

TOXICOLOGICAL INFORMATION: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is by injection only is an antidote. Contains petroleum distillate solvent.

DIRECTIONS FOR USE: Apply this product as it is purchased. DO NOT mix with water or oil.

Insect Pests Indoors: To control cockroaches, ants, crickets, earwigs, firebrats, fleas, silverfish, sowbugs, spiders and Brown Dog ticks, apply this product as a coarse spray or with a paint brush to localized areas where pests are found, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards, beneath and behind sinks, stoves, refrigerators and cabinets and around plumbing and other installations. Apply to point of runoff, approximately 5L/100 m².

For Carpet Beetles: Apply along baseboards and edges of carpeting, under carpets, rugs or furniture, in closets and on shelves. Repeat when pests reappear, but not more than once every 2 months.

NOTE: A period of 4 to 7 days is usually required for maximum effect on cockroaches.

USE PRECAUTIONS:

WARNING: Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food handling utensils with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces. Cover or remove all food before spraying. Remove pets and cover fish bowls(tanks) before spraying.

This product contains an oil base spray solution. DO NOT use as a general coverage spray in homes. Care should be exercised to ensure against staining of wall coverings or floor coverings with use of this product. DO NOT use around open flames or sources of heat.
