HANDLING AND STORAGE

Do not contaminate food or feed products.

Keep away from heat or open flame. Keep container closed. Use with adequate ventilation.

Store in original container.

FIRE FIGHTING

Wear impervious clothing and well contained breathing apparatus.

EVACUATE people downwind of fire. Avoid working downwind of fire.

Avoid heavy hose streams.

HOT CONTAINERS MAY EXPLODE. Keep a safe distance from fire in which these are present.

Dike area of fire to prevent pesticide runoff.

Decontaminate area before reuse.

SPILLS AND LEAKAGE

Isolate area and dike to prevent runoff.

Wear complete protective clothing, rubber gloves, rubber boots, coveralls, cap, etc.

Absorb spilled liquid in soda ash, clay, sweeping compound, etc. and transfer to container for disposal in accordance with the provincial regulatory agency.

Decontaminate area of spill.

DECONTAMINATION

Areas of leakage or spillage: Scrub with full strength chlorine bleach solution followed by water wash. Repeat several times. Bury washes. Wooden floors of transportation equipment are difficult to decontaminate and should be replaced.

DISPOSAL

Canadian formulators using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations.

DIRECTIONS FOR USE

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

CAN KILL YOU IF SWALLOWED

This product can kill you if swallowed even in small amounts: spray mist may be fatal if swallowed.

CAN KILL YOU BY SKIN CONTACT

This product can kill you if touched by hands or spilled or splashed on skin, in eyes or on clothing (liquid goes through clothes).

CAN KILL YOU IF BREATHED

This product can kill you if vapours or spray mists are breathed.

PRECAUTIONS

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL.

Do not get in eyes, on skin, on clothing.

Do not breathe vapour or mist.

Wash thoroughly before eating or smoking or using the toilet.

Bathe immediately after work and change all clothing.

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Remove unauthorized persons from operating area.

PROTECTIVE CLOTHING AND EQUIPMENT

Wear clean rubber gloves, goggles and clean waterproof or freshly-laundered protective clothing. Destroy and replace gloves frequently.

If you expect to be exposed to spray mist or water vapor, wear a respirator of a type approved by the National Institute of Occupational Safety & Health (NIOSH) for organic phosphate protection, such as ATX-2 respirator with Cartridge R21 and filter R15-Willson Products Division. Electric Storage Battery Co., Reading, Pa: Farm Spray Respirator (Improved) No. 93938 with 93939 GMP filter cartridge. Mine Safety Appliance Co., 201 North Braddock Ave., Pittsburgh Pa. 15208; Glenaire Respirator GR 2025 with C25 cartridge and F30 Prefilter-Glendale Optical Co. 130 Crossways Park Drive, Woodbury, L.I., New York 11797.

If handled indoors, provide mechanical exhaust ventilation.

Firefighters should use self-contained breathing apparatus and waterproof clothing.

ATTENTION

Do not use air pressure or apply heat with open flame to remove contents of drum.

After emptied, drum may retain solid, liquid, and/or vapour residues. Continue to observe all precautions on label.

Do not cut, puncture, torch, or weld on or near the emptied drum.

Do not use for other purposes.

FIRST AID

If swallowed, drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention or contact a poison control centre IMMEDIATELY.

If inhaled, remove to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. If breathing is difficult, give oxygen.

In case of contact, IMMEDIATELY flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Terbufos is a cholinesterase inhibitor. Typical symptoms of overexposure to cholinesterase inhibitors include headache, nausea, dizziness, sweating, salivation and runny nose and eyes. This may progress to muscle twitching, weakness, tremor in coordination, vomiting, abdominal cramps and diarrhoea in more serious poisonings. A life-threatening poisoning is signified by loss of consciousness, incontinence, convulsions and respiratory depression with a secondary cardiovascular component. Treat symptomatically.

If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as Pralidoxime Chloride, may be therapeutic if used early; however, use only in conjunction with atropine.

In cases of severe acute poisoning, use antidotes immediately after establishing an open airway and respiration. With oral exposure, the decision of whether to induce vomiting or not should be made by an attending physician.

ANTIDOTE

Atropine is an antidote. Consult your physician about obtaining a supply of 1/100 grain (0.6 milligram) tablets for emergency use. If symptoms include blurred vision, stomach cramps or tightness in chest, do not wait for a physician but take two tablets at once. Do not take atropine unless symptoms of poisoning have occurred. Anyone who has been given atropine must be seen by a physician as soon as possible.
