Purpose of Application

The purpose of this application was to amend the formulation of GOODNATURE CHOCOLATE PRE-FEED PASTE FOR RATS & MICE.

Chemistry Assessment

GOODNATURE CHOCOLATE PRE-FEED PASTE FOR RATS & MICE is formulated as a paste containing canola oil at a concentration of 78.5%. This end-use product has a density of 0.97 – 0.99 g/cm³. The chemistry requirements for this product have been fulfilled.

Health Assessments

GOODNATURE CHOCOLATE PRE-FEED PASTE FOR RATS & MICE is considered to be of low acute toxicity by the oral, dermal and inhalation routes, mildly irritating to the eyes and skin, and not expected to be a dermal sensitizer.

Under this application, a change in formulation was submitted and reviewed.

There is no potential for occupational exposure since the product is for domestic use.

The risks to bystanders and individuals in residential areas are acceptable when GOODNATURE CHOCOLATE PRE-FEED PASTE FOR RATS & MICE is used according to label directions. Precautionary and directions for use statements on the product label aimed at mitigating residential exposure are considered adequate to protect individuals from any potential risk due to exposure.

There are no food or drinking water concerns when the product is used according to label directions.

Environmental Assessment

An environmental assessment was not required for this application.

Value Assessment

The amendments in formulation in GOODNATURE CHOCOLATE PRE-FEED PASTE FOR RATS & MICE were supported based on the biological equivalency of the new formulation compared to the previously registered formulation and no changes to the use pattern.

Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found the information acceptable to support the registration of the amended formulation of GOODNATURE CHOCOLATE PRE-FEED PASTE FOR RATS & MICE.
